



ACCEPTABLE FORMS OF ID

FBI Channeler eligibility:

The applicant must be a US citizen or Lawful Permanent Resident ("Green Card" holder).

Identification Requirements:

2 forms of identification. The primary ID must be valid, unexpired, government-issued, photo ID. We cannot accept expired/punched ID, pictures or scans.

Most applicants only need to show a valid driver license with their current address.

If your primary ID **does not** have your address or your address is not current, you will need to bring 1 form of identification to verify your identity + 1 document to verify your address.

PRIMARY LIST - Bring 1 List A document showing your current address or (1 List A + 1 List C document)

List A (Must be valid, unexpired, government-issued, photo ID. We cannot accept expired/punched ID, pictures or scans.)

- State-issued driver's license
- U.S. Passport or U.S. Passport Card
- Federal Government Personal Identity Verification Card (PIV)
- Uniformed Services Identification Card
- Department of Defense Common Access Card
- Foreign Passport with Appropriate Immigration Document(s)
- USCIS – Permanent Resident Card (I-551) ("Green Card")
- USCIS – Employment Authorization Card (I-766)
- Federal, state, or local government agency ID card with photograph
- U.S. Coast Guard Merchant Mariner Card
- Canadian driver's license
- State ID card if the state's identification card standards are the same as for the driver's license
- U.S. Tribal or Bureau of Indian Affairs Identification Card

List B (in the absence of a List A document, present 2 List B documents + 2 List C documents):

- State Government Issued Certificate of Birth (certified copy)
- Native American tribal document
- Social Security Card
- Court Order for Name Change/Gender Change/Adoption/Divorce (certified copy)

ACCEPTABLE FORMS OF ID

- Marriage Certificate (Government Certificate Issued) (certified copy)
- U.S. Government Issued Consular Report of Birth Abroad (certified copy)
- Draft record (certified copy)
- School ID with photograph (minors only)
- Certificate of Citizenship (N-560)
- Replacement Certificate of Citizenship (N-561)
- Certificate of Naturalization (N-550)
- Replacement Certificate of Naturalization (N-570) (with photo)

List C – Secondary/supporting documents (address verification document- must match your current name and address)

- Utility Bill (Address)
- Jurisdictional Voter Registration Card
- Vehicle Registration Card/Title
- Paycheck Stub with Name/Address – the financial information can be redacted (removed, marked out, or otherwise hidden)
- Jurisdictional Public Assistance Card
- Spouse/Parent Affidavit
